# History

- Formed 18 January 1933 1<sup>st</sup> President P. Hill
- First AGM 20<sup>th</sup> December 1933
- Initial premises 221 Nelson Place Williamstown
- Association with Ballarat Anglers Club 1934
- 30 July 1941 Current Clubrooms opened
- Feb 1942 Jetty and slipway opened
- 1961 Boathouse opened
- 1976 Jetties and slipway replaced
- 2010 Clubrooms / Boathouse re-clad

- 3<sup>rd</sup> Wednesday maintenance night
- 4<sup>th</sup>/5<sup>th</sup> Wednesday social and draw for comp
- Committee Meetings
  - Usually 1<sup>st</sup> Monday month
  - $\circ\,$  Raise items prior to meeting in writing / email

#### **General By-Laws**

- Visitors to comply with all Club Rules
- Club Boats restricted to Club members
- Loan of Club equipment approved by Committee
- Angling not permitted during Club meetings / working bees
- Compulsory to weigh in and record fish caught
- 12 months membership before applying storage / slippage / boat captain
- No boat launched while Bay Comp in progress unless participating
- Smoking is prohibited inside buildings
- Members nominating for outing where fee involved are liable for fee
- Visitors using facilities on 5 occasions must join club before using facilities again
- Renewable Liquor Licence



#### **Competition By-Laws**

- Members must be Financial with current fishing license
- Competitions listed on Syllabus
- Judge & Stewards for each Competition appointed by Members
- Competition Folder outlines responsibilities of Judge / Stewards
- Judge / Stewards have full control / authority
- Timings & type of Comp set at Wed meeting prior to Comp
- Crews for boats drawn by ballot
- Late fees apply to nominations on the day
- Competitors report & sign on ½ hr prior to Comp start
- Competitors sign off before Comp finish time
- Cannot fish prior in nominated waters on the day of the Comp



## Competition By-Laws (2)

#### • Equip:

- Rod & line only (no handlines)
- Max 3 rods with Max total of 3 hooks
- State regulations take precedence
- Only fish listed on Club Schedule able to be weighed in
- Fish for weighing presented in a container with tag of Name and Competitor number but free of other items / excess water
- Protests lodged with Secretary within 7 days
- Disqualification for season for presenting undersized fish
- One visitor per member per season can be invited to compete
- Visitors (max 2 per comp) nominated Wed nights



#### Competition By-Laws (3)

- Boats used in Competitions launching from alternate mooring / ramps
  - Size Min length 3.962m x 1.600m Beam
  - Fitted with spray hood where necessary
  - Inspected by Committee



## Trophies / Awards

- Season Champion T.G. Marr Memorial Trophy
- Junior Champion
- Non-Boat Owner Champion (Boat Captains ineligible)
- Club Member of the Year F.J. Martin Memorial Trophy
- Dennis Memorial Trophy (1<sup>st</sup> Freshwater,1<sup>st</sup> Bay, 1<sup>st</sup> bay Snapper)
- Jim De Rose Trophy (heaviest bag caught)
- Simon Waters Trophy (largest snapper in competition)
- Martin Bowyer Presidents Day Trophy (secret weight)
- Ballarat / WNAC Trophy
- George Chamings Trophy (largest Snapper in Ballarat visit)



### **Building By-Laws**

- Boat Owners / Boat Captains take an active and personal interest
- Boat Owner produce annually registration, public liability insurance (\$10M)
- Committee can request floors be fitted in boats
- Cleaning of fish prohibited on slipway
- Walking behind boats on slipway prohibited
- Boats must meet Dept of Safety & Transport regs incl. safety equip
- Boats measured by Committee for Storage or Slippage
- Lockers
  - No paints or flammables kept in lockers
  - Solo hire or shared (2 person maximum)
  - Subject to annual locker fee



### Building By-Laws (2)

- Boat Storage space allocated within Boathouse
  - Size Max 4.7m length x 2.150m beam (incl. trailer width)
  - Fixed canopy and cabins that allow access to anchor well
  - Committee determines storage locations
  - No engine running in boatshed
  - Bungs must be fitted or Club container used when in Boat House
  - Three (3) months to occupy space from allocation
- Slippage trailer boat to and from Club
  - Max length 5.029m x 2.224m beam
  - Must have windscreen that allows access to anchor well
  - Fitted spray hood where necessary



# Kayaks (1)

- Kayaks for slippage or storage must comply with State regulations and include:
- Length min. 2m
- Manufactured to AN/NZS 4766:2006 or similar standard
- Bouyancy material inside hull
- Designed for angling
- All round white light (after dusk/before dawn)
- Waterproof/buoyant torch (after dusk/before dawn)
- Anchor and chain/rope



# Kayaks (2)

- Sponge (car)
- Safety whip flag
- Hand held paddle
- Bucket/bailer w lanyard
- Electric or manual bilge pumping system (if kayak has covered bilge or closed underfloor compartments other than airtight void space.



# Categorization of Boat Owners and Annual Storage Fees By-Laws

#### Active Boat Owners

- Boat participated in 3 or more syllabus bay competitions
- Noncommercial storage fee for subsequent season

#### Non-Active Boat Owner

- Boat participated in less than 3 syllabus bay competitions
  Commercial storage fee for subsequent season
- Participation by Boat Owner or Boat Captain
- Seasonal Categorization by Committee in June
- Boat Owner can apply for categorization / special consideration
- Compliance with all rules / by-laws despite categorization

#### Rules for Hire of Club Boats By-Laws

- Record booking on hire sheets
- Payment at time of booking with money in office mail slot
- No weekly bookings
- Bookings for Sunday only after Wednesday meeting
- Apply for solo hire after 3 months active boating
- Limits to designated area for fishing
- Clean boat on return including flush motor
- Record amount of fuel left in tank
- Any loss or damage to be reported to Secretary
